The State Property Management Divisions at Provinces and Vientiane Capital where there is a registration service unit of selling-purchasing agreements and import-export agreement at warehouses that should follow the calculation method in the Article 06, Section 06 (paragraph 03) of the President Decree on the fees and charges (updated) No. 003/POL, dated 26 December 2012.
